CANCELLATIONS OR RESCHEDULING:

If CMFD, LLC's speaking engagement is canceled due to an Act of God or dangerous situation, all parties agree to use good faith efforts to reschedule the event with the same terms as stated in the initial Agreement. If despite such efforts the parties cannot agree on a new date for the event, or if ██████████ E██████████ cancels the scheduled speaking engagement for any reason, the remaining engagement fees will be due and payable no later than the original date of the event, along with all reimbursable expenses hereunder to the extent incurred and are not refundable.

Additionally If the engagement date and or location changed within 30 days of the scheduled event, without written agreement from CMFD, ██████████ is responsible for reimbursing CMFD, LLC, for any airfare expenses incurred.
